## FORMAL COMPLAINT AGAINST:

Please find enclosed articles and correspondence which details the conduct of the above-mentioned veterinary surgeons. It is my contention that they have neglected their responsibilities and abused their positions of trust within the veterinary profession.

## Specifically: -

- 1. Published material deficient in objective facts which, if left uncorrected, must be perceived by the readership as being substantially true.
- 2. When provided with a fuller, more accurate explanation, instead of promptly publishing that explanation engaged in undue procrastination.
- 3. Reversed their decision to publish the letter, which constitutes:
  - a. A disgraceful resolution of the Association and
  - b. Was disgraceful in the manner in which the decision was communicated.



- 4. Provided contrived explanations for unconscionable conduct.
- 5. Provided mutually inconsistent explanations which must render either or both of those explanations untrue.

Letters to the editor are a feature of our democracy where the authors' opinions are open to interpretation by the readership. In a self-regulating profession the need for open flow of information and opinion is necessary in order to avoid loss of the privilege of self-regulation.

It is my view that the above-mentioned veterinarians have sullied the name of the profession by suppressing information which could help veterinarians to alleviate much suffering and distress amongst their patients and thus suffering and distress amongst the owners of those patients.

Please, I urge, investigate this matter in accordance with the magnitude of the alleged breaches. Please take such steps to ensure a remedy in the present instance and further ensure that such conduct is never repeated.

Please find enclosed documentation detailing alleged unprofessional conduct by a group of senior veterinary surgeons at the British Small Animal Veterinary Association.
