The Australian Competition and Consumer Commission are to be observers on the Pet Food Review Working Group at this time.
- Include a definition of pet food in the TOR and what would be in scope for this review. The question was raised does it include meat sold at butcher shops as pet meat. Meat sold at butcher shops is out of scope of this review.
- A question was raised about whether the Agriculture Senior Officials Committee (AgSOC) needed to approve the terms of reference for the group. More information will be provided on the level of oversight by AgSOC and the timing of AgSOC meetings. Include reference to providing a report to AgSOC in the TOR.

Action Item 1: Members of the group are to send specific comments on the terms of reference for the group to s. 22(1)(a)(ii).

Action Item 2: Secretariat to propose a definition of pet food, for the purpose of the review, so it can be discussed at the next teleconference meeting.
